OFFICIAL CONTEST RULES ("Contest Rules")

1. ELIGIBILITY

- (1) The #ThatsSoDad Contest ("Contest") is open only to Hydro Ottawa Residential Customers who are, at the time of Contest entry:
 - (i) legal resident of Canada; and
 - (ii) If an individual, at least 18 years of age.
