- <sup>4</sup> For Standard Supply Service customers (not purchasing the electricity commodity from an electricity retailer), a monthly administration fee of \$0.25 is added to the regulatory charge to recover a portion of the cost of systems required for the market.
- <sup>5</sup> For customers of the former Casselman Hydro, this rate is \$0.007/kWh, as Casselman Hydro did not own any generating plants.



### **Understanding your bill**

In order to simplify hydro bills, some charges are combined to create fewer line items.

While your total bill is paid to Hydro Ottawa, the distribution charges included in the delivery cost are the only ones retained by Hydro Ottawa. The rest of the charges are collected on behalf of others and passed through to you without any markup.

### **Electricity Charge**

This is the cost of the electricity supplied to you during a billing period and is based on the wholesale electricity market pricing. The electricity consumed is multiplied by the adjustment factor (see Adjusted Consumption). Hydro Ottawa collects this money and pays this amount directly to its suppliers.

### **Delivery Charge**

These are the costs of delivering electricity from generating stations across the province to Hydro Ottawa then to your business. This includes the costs to build and maintain the transmission and distribution lines, towers and poles, and operate provincial and local electricity systems. Hydro Ottawa passes the transmission and low voltage services charges through to you, without a mark-up, on behalf of Hydro One.

A portion of these charges are fixed and do not change from month to month. The rest are variable and increase or decrease depending on the amount of electricity that you use.

#### **Global Adjustment**

The price of generation in Ontario is set by a competitive market. Certain generators receive payments through regulation or contract that differ from the market price. The portion of the net adjustment arising from these different payments is included as the Global Adjustment on a large customer's bill.

### **Regulatory Charges**

Regulatory charges are the costs of administering the wholesale electricity system and maintaining the reliability of the provincial grid and include the costs associated with funding Ministry of Energy conservation and renewable energy programs.

### **Debt Retirement Charge**

The debt retirement charge pays down the stranded debt of the former Ontario Hydro.

# Other Items That Appear on Your Bill

### **Peak Billing Demand**

The peak power used during the billing period is billing demand. It is billed using the measured kilowatts (kW) or 90% of the kilovolt-amps (kVA), whichever is greater.

### Consumption

This is the amount of electricity you use in kWh.

### **Adjusted Consumption**

When electricity is delivered over a power line, it is normal for a small amount of power to be consumed or lost as heat. Equipment, such as wires and transformers, consumes power before it gets to your business. The adjustment factor accounts for these losses. The delivery and regulatory charges are based on the adjusted consumption, which is calculated by applying a regulated factor to the metered consumption.

The regulated factors for customers with a billing demand less than or equal to 5,000 kW is:

- 1.0254 for customers with primary meter, or
- 1.0358 for customers with secondary meters.

The regulated factors for customers with a billing demand greater than or equal to 5,000 kW is:

- · 1.0069 for primary meters, or
- 1.0170 for secondary meters.

The debt retirement charge is based on pre-adjusted consumption.

### **Business Charges and Credits**

Customers who own transformers that step down from Hydro Ottawa's primary supply voltage to the utilization voltage will automatically receive a **Transformer**Ownership Credit (TOC) per kW of billing demand of \$0.45 for transformation from less than 115 kV.

Where dry core transformers are located after the primary transformers and the metering is on the customer's side of the dry core transformers, a Drycore Transformer Energy Loss Charge (cost of power and delivery charge) for unmetered losses applies. This charge is based on the size of the dry core transformer.

New accounts are subject to an **Account Set-up Charge** of \$30.00. This charge also applies when there is a change of occupancy.

A Credit Check Charge of \$15.00 may be required for new customers who have never had hydro bills in their name, or have moved from outside Hydro Ottawa's service territory.

A **Security Deposit** may be applied to any account as a condition of service.

An administrative charge of \$15.00 applies per duplicate invoice on previously printed bill copies and/or per year of billing or reading history.

An Arrears Certificate Charge of \$15.00 covers the cost of investigating whether an outstanding balance exists.

To avoid interest charges, payment must be received by Hydro Ottawa on or before the **Due Date**. It is important to allow sufficient time for your payment to be received and processed, taking into account the time required for payment to be transferred from your financial institution or delivered by mail.

An unpaid balance after the due date is subject to an **Interest Charge** of 1.5% per month, compounded monthly (19.56% per annum).

A Returned Payment Charge of \$15.00 plus any bank charges is applied when cheques are returned NSF on an account.

A Collection of Account Charge of \$30.00 is applied for payments collected at a customer's premises when the account is scheduled for disconnection.

Reconnection Charges vary and are based on the type of electrical service and time of day.\*

A Temporary Service Installation/Removal Charge of \$500.00 applies for temporary service connection.

For customers with load displacement generators > 500 kW a variable **Standby Charge** applies per kW of contracted demand for a month where standby power is not provided.
